1. RBI released the list of 15 NBFCs in 'Upper Layer '



The Reserve Bank of India has released the list of 15 NBFC companies making a place in the upper layer for the financial year 2024. RBI has made regulation rules to prevent the expansion of NBFC companies and the impact of the risks associated with them from increasing on other sectors. These rules are applicable at different levels for NBFC companies included in different layers of RBI. The same rules as banks apply to NBFC companies included in the upper layer list of RBI. RBI has released the list of 15 NBFCs included in the upper layer under the Scale Based Regulation for Non-Banking Financial Corporations (NBFCs) for the financial year 2024. LIC Housing Finance Limited is at first place in the list. After that Bajaj Finance Limited is at second place and Shriram Finance Limited is at third place. TMF Business Services Limited (formerly Tata Motors Finance Limited) has not been included in the list despite qualifying due to its ongoing business restructuring. However, Tata Sons Private Limited has got the fourth place in the list. Similarly, L&T Finance Limited has got the fifth place. NBFCs falling outside the predefined categories, such as investment and credit companies (NBFC-ICC), micro finance institutions (NBFC-MFIs), NBFC-factors, and mortgage guarantee companies (NBFC-MGC), based on various parameters prescribed by the RBI. But regulations can be placed in any category of the structure. The introduction of the SBR framework by RBI has significant implications for the NBFC sector in India. This allows for a more nuanced and risk-based approach to regulation, ensuring that NBFCs are subject to appropriate levels of supervision depending on their size and activities.

2. 84 artists were honored with Sangeet Natak Akademi Amrit Award.



Vice President Jagdeep Dhankhar presented the onetime Sangeet Natak Akademi Amrit Award to 84 artistes from various fields of performing arts. The award was instituted to honor Indian artists above the age of 75 who have not been awarded any national honor so far in their career. A total of 84 artists, including 70 men and 14 women, were honored with this prestigious award at the ceremony. The list also includes three artists from Andhra Pradesh, two from Arunachal Pradesh and six from Maharashtra. Additionally, three awardees each from Uttar Pradesh, Gujarat as well as two awardees each from Punjab and Delhi were also recognised. An equal number of four honorees were received from Bihar, Odisha, West Bengal, Manipur, Madhya Pradesh, Tamil Nadu, Kerala and Karnataka for their extraordinary contribution. Moreover, five persons each from Assam and Rajasthan were awarded this prestigious honour. Some of the award winners include Raghubir Malik and Dina Nath Mishra for Hindustani singing, Gauri Kuppuswami and Anasuya Kulkarni for Carnatic singing, Lalitha Srinivasan and Vilasini Devi Krishnapillai for Bharatanatyam and Smita Shastri and Kumkum Lal for Kuchipudi and Odisha. The awardees also include folklorists like Jharkhand's Mahabir Nayak for music, Maharashtra's Harishchandra Prabhakar Borkar for theatre, and Assam's Dharmeshwar Nath for dance.

3. Imports and exports remained low in August, trade deficit was 24.16 billion dollars.



According to the data released by the government, India's exports have decreased in August this year. India's exports declined by 6.86 per cent to US\$ 34.48 billion in August this year due to decline in shipments from key sectors like petroleum and gems and jewelery due to weak global demand. Exports in the same month a year ago were \$37.02 billion. Exports of iron ore, electronic goods, oil seeds, cashew nuts, carpets, engineering, pharma and marine products have increased in August. Apart from this, export of electronic goods increased by 26.29 percent to 2.17 billion dollars. In a period of five months it increased by 35.22 percent to \$ 11.18 billion. Services exports are estimated at US\$26.39 billion in August, up from US\$26.5 billion a year ago. The estimated value of services exported in April-August 2023 was US\$ 133.38 billion, while it was US\$ 126.85 billion in April-August 2022. Apart from exports, imports into the country have declined for the ninth consecutive month last month. Imports declined by 5.23 percent to US\$ 58.64 billion, compared to US\$ 61.88 billion in August 2022. Oil shipments declined 23.76 percent to US\$13.2 billion in August. During April-August 2023, it declined by 23.33 percent to US \$ 68.3 billion. However, gold imports increased by 38.75 percent to \$4.93 billion in August. During April-August 2023, it increased by 10.48 percent to \$ 18.13 billion. Talking about total imports, it was US \$ 13.86 billion as against US \$ 15.22 billion in August. The trade deficit (the difference between imports and exports) remained almost stable at US\$24.16 billion in August.

4. Famous writer Geeta Mehta passes away



Famous writer-filmmaker Geeta Mehta passed away. She was 80 years old. Mehta had written books like Karma Cola, Snakes and Ladders, A River Sutra, Raj and Eternal Ganesha. He also produced and directed at least

14 television documentaries for UK, European and American networks. His film 'Dateline Bangladesh', based on the Bangladesh Liberation War of 1971, was shown in theaters both in India and abroad. Mehta's books have been translated into 21 languages and have been on bestseller lists in Europe, the United States and India. Geeta Mehta was the daughter of famous Odisha politician and former Chief Minister Biju Patnaik and elder sister of current CM Naveen Patnaik. Geeta Mehta was married to the famous American publisher. late Sunny Mehta. Geeta Mehta, daughter of Biju Patnaik and Gyan Patnaik, was born in 1943 in Delhi. Geeta Mehta was educated in India and Cambridge University, UK. Geeta Mehta had written five books named Karma Cola, Snakes and Ladders, A River Sutra, Raj and The Eternal Ganesha. Geeta Mehta came into limelight in the year 2019 when she refused to accept the prestigious Padma Shri award for literature and education. Geeta Mehta was very close to her younger brother Naveen Patnaik.

5. Railway Ministry launches 'Swachhta Pakhwada-2023'



Under the Swachhta Pakhwada in Katihar Railway Division area, a huge Prabhat Pheri was organized with the aim of spreading awareness about cleanliness among the railway employees and railway customers. In this, all the railway officers, employees, officials of recognized trade unions and welfare organizations and members of Scott and Guide participated enthusiastically. The inauguration of Prabhat Pheri started from the Divisional Railway Manager's office and ended with the organization of street drama at Katihar Junction. It is noteworthy that Katihar Railway Ministry is celebrating Swachhta Pakhwada from 16th September to 02nd October. This year the activities of SHS have been integrated with the Swachhta Pakhwada program of Indian Railways. In this context, Senior DPO

of Katihar Railway Division Atul Kumar Mishra said that for Swachhta Pakhwada 2023, dedicated days have been fixed for activities like clean trains, clean stations, clean food and clean tracks etc. during the fortnight. It is also planned to run a massive awareness campaign through digital media and public announcement through PA system to encourage people to use biotoilets, avoid single-use plastic and adopt hygiene habits.

6. International Red Panda Day 2023: A call to protect the red panda



Every year, on the third Saturday of September, the world comes together to celebrate International Red Panda Day, dedicated to raising awareness about the plight of these loveable creatures. This year, on September 16, we once again unite in our efforts to protect the red panda, which stands at the brink of natural abundance. Launched in 2010 by the Red Panda Network, this annual observation has grown in importance over the years, especially as we face the problems posed by global warming and climate change. International Red Panda Day made its debut in September 2010, with the aim of highlighting the critical conservation needs of the red panda. These fascinating animals are native to the eastern Himalayas, which span areas of China, Nepal, and Bhutan. Unfortunately, they face imminent danger mainly due to human activities. Poaching has become another serious threat. Red panda fur is illegally trafficked to produce hats and clothing, reducing their population. To address these concerns, several countries, including India, Bhutan, China, Nepal, and Myanmar, have taken measures to legally protect the red panda. However, enforcement remains weak in many areas, contributing to the decline of the species. The Himalayan region, where red pandas primarily reside, faces challenges in maintaining law and

order, allowing poaching to persist. Complicating the issue, the Nepalese government lacks adequate funding for research and conservation efforts, leaving these animals in a precarious situation. This dire situation has led the International Union for Conservation of Nature (IUCN) to classify the red panda as 'endangered', emphasizing the urgent need for action.

7. Director of Dhanlaxmi Bank resigns from board membership.



Dhanlaxmi Bank Director Sridhar Kalyanasundaram has resigned, making several serious allegations against the board. He has accused the board of unethical conduct, one-sided arrogance of power, lack of understanding of the issues and factionalism. Let us tell you that Kalyanasundaram has taken this resignation before the Annual General Meeting of the bank which was to be held on September 30. Director Sridhar Kalyanasundaram, in his resignation letter, has accused the bank and said that there is a lot of internal dispute in the board. In his resignation letter, Kalyanasundaram has raised issues like factionalism in the board, their differences on the issue of rights and the alleged 'lack of in-depth banking knowledge' among other members. The former independent director also raised "lack of honesty and consensus" on various whistleblower issues as the reason for resignation. He said that he was dismissed despite the board receiving many complaints. This comes after RP Group chief Raveendran Pillai, who holds 9.99 per cent stake in the bank (the largest shareholder), issued a special notice to remove Kalyanasundaram. A resolution in this regard will be passed in the 96th Annual General Meeting (AGM) to be held on September 30. The bank had previously received complaints from other 'whistle-blowers', but Kalyanasundaram said the bank had ignored them all,

calling them "a habit of this bank over time". The director also alleged that the bank is using the one-time settlement scheme without having any meaningful impact on its non-performing assets. The NPA ratio at the end of June was 5.2%. Now it will be interesting to see how RBI will address the alleged lack of governance in the bank.

8. India won Asia Cup for the 8th time, defeated Sri Lanka by 10 wickets



In the final match of Asia Cup 2023, India defeated Sri Lanka by 10 wickets. India has won this title for the 8th time. Sri Lanka had scored 50 runs while batting first. Sri Lanka won the toss and batted first in the title match played at R Premadasa Stadium in Colombo. However, the Indian bowlers wreaked havoc. In front of the stormy bowling of Mohammed Siraj, Hardik Pandya and Jasprit Bumrah, the Sri Lankan innings was reduced to 50 runs in 15.2 overs. Siraj took six wickets, while Hardik got three wickets. Bumrah took one wicket. In reply, India won the match in just 37 balls. Team India won the final by 10 wickets. Shubman Gill remained unbeaten on 27 runs in 19 balls and Ishan Kishan remained unbeaten on 23 runs in 18 balls. Shubman hit six fours and Ishaan hit three fours in his innings. India has defeated Sri Lanka by 10 wickets in the final of Asia Cup. Team India won this title for the eighth time. Earlier, India had won the title in 1984, 1988, 1990-91, 1995, 2010, 2016 and 2018. India has won this tournament seven times in ODIs and once in T20, while the Sri Lankan team has won this title six times. Sri Lanka has won the title five times in ODI and once in T20. Pakistan team has become champion twice. Prime Minister Narendra Modi has congratulated Team India on winning the Asia Cup title.
