



1. Tata Motors will buy 27% stake in Freight Tiger



Tata Motors recently said it will buy 26.79 percent stake in digital logistics solutions company Freight Tiger for Rs 150 crore. Tata Motors entered into a Securities Subscription Agreement (SSA) and a Shareholders Agreement (SHA) to buy this stake in Freight Tiger. The SSA includes a provision that Tata Motors will also be able to invest another Rs 100 crore at the current market price over the next two years. Freight Tiger is a digital platform that provides end-to-end logistics value chain solutions for freight movement in the country. The platform acts as a digital marketplace, connecting shippers, carriers, logistics service providers and fleet owners. This connection simplifies the process of searching, booking and managing freight, making it more efficient for all stakeholders involved. Freight Tiger offers a suite of SaaS solutions to digitalize and streamline various aspects of logistics interactions. These solutions include freight tracking, assignment management, carrier matching, documentation and payment processing. Over the past seven years, the platform has successfully integrated and eliminated inefficiencies in cargo movements, handling over 10 million journeys on an annual basis. Tata Motors has been actively involved in the digitalization of fleet operations through its connected vehicle platform, 'Fleet Edge'. 2. Google launches DigiKavach to tackle online financial fraud

4. India created history in space, ISRO successfully launched the first test flight of Gaganyaan.



ISRO has created history by launching the first test flight of Gaganyaan mission. ISRO successfully launched the crew module of Gaganyaan from the Satish Dhawan Space Center in Sriharikota. It is also being called Test Vehicle Abort Mission-1 and Test Vehicle Development Flynt (TV-D1). The test vehicle took with itself the crew module built for the astronaut. The rocket will go up sixteen and a half kilometers carrying the crew module and then land in the Bay of Bengal. Earlier the test mission was to be launched at 8 am but unfortunately it was rescheduled for 8.45 am. But before the launch, the engines could not function properly due to which the launch was postponed. Earlier, on postponement of the launch, ISRO chief had said that we are finding out what went wrong. He said, 'The test vehicle is completely safe but the engines could not be started on time. ISRO will analyze the flaws and it will be rectified soon. Lift closing time has been postponed. For some reason the automatic launch was interrupted and the computer stopped the launch, we will analyze the flaws manually. The success of this test flight will determine the outline of all further planning of the Gaganyaan mission. After this, there will be another test flight next year in which humanoid robot Vyommitra will be sent. Abort test means that if there is any problem, this module along with the astronaut can bring them down safely. ISRO said that the single-stage liquid propulsion rocket equipped with the 'crew module' (which will carry the astronauts) and the crew rescue system was lifted off from the first launch pad of the space centre. The objective of the test spacecraft mission is to study the safety parameters of the crew module and crew rescue system to eventually return Indian astronauts to Earth under the Gaganyaan mission. The Gaganyaan mission

aims to send humans into low Earth orbit at an altitude of 400 kilometers in a three-day mission in 2025 and bring them back to Earth safely. Indian astronauts i.e. Gagnauts will sit inside the crew module and revolve around the Earth in a low orbit at an altitude of 400 kilometers. ISRO will attempt the successful launch of its Test Vehicle – Demonstration (TV-D1), a single stage liquid propulsion rocket. This test vehicle mission with the crew module is an important milestone for the overall Gaganyaan programme.

6. Kotak Mahindra gets RBI nod to acquire Sonata Finance for ₹537 crore



Kotak Mahindra has received approval from the Reserve Bank of India to acquire Sonata Finance for Rs 537 crore. Shares of Kotak Mahindra Bank were trading 1.68% higher at ₹ 1767.50 per share on BSE. The bank had announced the purchase of 100% stake in nonbanking finance company Sonata Finance Private Limited in February this year. The acquisition received RBI approval on October 19, the company said in its stock filing. After completion of the transaction, Sonata will become a 'wholly owned subsidiary of the bank'. RBI has given its approval to the Bank to acquire 100% of the issued and paid-up capital in Sonata, vide its letter dated October 19, 2023, received by the Bank. This approval has been given by Kotak Mahindra before the announcement of its September guarter results. The bank is set to announce its Q2 results on October 21. Earlier, Kotak Mahindra had bought BSS Microfinance in an all-cash deal worth Rs 139 crore in September 2016. This acquisition helped the company gain its foothold in the southern part. However, Tapobrata Choudhary, president and head microfinance business at Kotak Mahindra Bank, told Moneycontrol that Sonata Microfinance will help the company expand its presence in the northern states. The company reported a 50.62 per cent rise in its consolidated net profit at Rs 4,150.19 crore in the first

quarter of the current financial year. The sharp rise in its PAT was a result of growth in net interest income and improvement in asset quality.

7. RBI imposes ₹2.5 crore fine on L&T Finance for non-compliance



The Reserve Bank of India (RBI) has taken regulatory action against L&T Finance Ltd by imposing a monetary penalty of ₹2.50 crore on the company for noncompliance with specific provisions. The Reserve Bank of India (RBI) has recently taken regulatory action against L&T Finance Limited by imposing a monetary penalty of ₹2.50 crore (Rupees Two Crore Fifty Lakhs only) on the company. The decision comes in the wake of the statutory inspection of L&T Finance Ltd, which covered its financial position as of March 31, 2021 and March 31, 2022. According to a press release issued by the RBI, the penalty was imposed for non-compliance with specific provisions of the Non-Banking Financial Companies - Systemically Important Non-Deposit Taking Companies and Deposit Taking Companies (Reserve Bank) Guidelines, 2016. Is. RBI's decision to impose the monetary penalty on L&T Finance Ltd has been taken after a comprehensive statutory inspection, in which the financial position of the company was assessed as of two key dates, March 31, 2021 and March 31, 2022. This inspection included the examination of various reports and correspondence relating to the company's operations. In response to the deficiencies identified, RBI issued a notice to L&T Finance Limited. In this notice, the company has been requested to show reasons why penalty should not be imposed for non-compliance of RBI instructions. The notice initiated a process for L&T Finance Ltd to provide clarification and defense against the alleged noncompliance.

8. Indian Navy gets third guided missile destroyer Imphal



The state-of-the-art stealth guided missile destroyer, Yard 12706 (Imphal) has been officially transferred to the Indian Navy on October 20, 2023. In a significant development for the Indian Navy, the state-of-the-art Stealth Guided Missile Destroyer, Yard 12706 (Imphal) has been officially transferred to the Indian Navy on October 20, 2023. This momentous occasion is a major milestone for India. Indigenous shipbuilding capabilities are enhancing its maritime strength in the Indian Ocean region. Imphal is the third ship of Project 15B which was built at Mazagon Dock Shipbuilders Limited (MDL). The project is a follow-up to the Kolkata class (Project 15A) destroyers commissioned in the last decade. Imphal follows predecessors Indian Naval Visakhapatnam and Mormugao, commissioned in the last two years. Imphal, designed by the Indian Navy's Warship Design Bureau (WDB) and built by Mazagon Dock Shipbuilders, stands as a symbol of India's strength in indigenous shipbuilding. With a displacement of 7,400 tonnes and overall length of 164 metres, this guided missile destroyer boasts of advanced armament including surface-to-air missiles and torpedoes and state-of-the-art sensors. Imphal, powered by a combined gas and gas (COGAG) propulsion system consisting of four gas turbines, can achieve a speed of more than 30 knots (56 km/h). This remarkable speed and agility makes the destroyer a formidable presence on the high seas, able to react rapidly to any situation. Imphal boasts of a high indigenous content of about 75%. This includes medium-range surface-to-air missiles (BEL, Bengaluru), BrahMos surface-to-surface missiles (BrahMos Aerospace, New Delhi), indigenous torpedo tube launchers (Larsen & Toubro, Mumbai), indigenous anti-submarine missiles. Rocket Launcher (Larsen & Toubro, Mumbai) and 76 mm Super Rapid Gun Mount Haridwar). This reliance on indigenous technology reflects India's ability to produce world-class military equipment.

incomprehensible puzzle for the batsmen of his generation. He used to release the ball as high as possible and his control was amazing. Bedi made her Test cricket debut on 31 December 1966 against West Indies at Eden Gardens, Kolkata and remained a part of the Indian team till 1979. Meanwhile, he played 67 test matches in which he took 266 wickets at an average of 28.71. Bedi has 1560 wickets in her name in first-class cricket.
