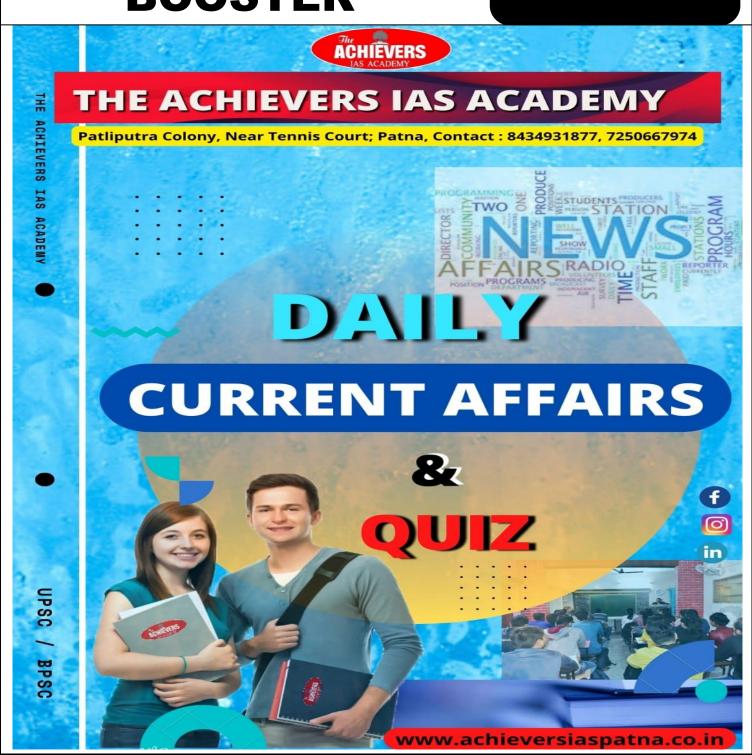

1. 97.26% of ₹2000 notes returned to banks, RBI revealed



The Reserve Bank of India (RBI) has achieved a significant milestone in its monetary policy as it has successfully withdrawn 97.26 per cent of ₹2,000 bank notes from circulation by May 19, 2023. The Reserve Bank of India (RBI) has achieved a significant milestone in its monetary policy as it has successfully withdrawn 97.26 per cent of ₹2,000 bank notes from circulation by May 19, 2023. This step was initiated to serve its purpose. These notes were to meet the currency requirements of the economy after the withdrawal of legal tender status of all ₹500 and ₹1,000 bank notes in circulation during the demonetization of November-December 2016. In November and December 2016, India witnessed a historic demonetization process when the government decided to invalidate all ₹500 and ₹1,000 bank notes in circulation. This bold step was aimed at curbing black money, fake currency and promoting digital transactions. To replace the void created by demonetization, RBI introduced ₹2,000 bank notes with advanced security features to ensure their authenticity. Fast forward to May 19, 2023, when the RBI announced the withdrawal of ₹2,000 bank notes. The total value of these notes in circulation at that time was Rs 3.56 lakh crore. The objective of introducing these notes was essentially accomplished as bank notes of other denominations became available in sufficient quantities. This marked the beginning of the withdrawal process. The withdrawal process, which lasted for several months, is nothing less than a remarkable success. As of November 30, 2023, the total value of ₹2,000 bank notes in circulation has declined to ₹9,760 crore, showing a significant decline from the initial ₹3.56 lakh crore.

2. Orissa's daughter Manisha Padhi becomes India's first Woman Aide-De-Camp

Earlier, Squadron Leader Manisha Padhi has been posted at three Air Force Stations including Bidar, Air Force Station Pune and lastly Air Force Station Bhatinda.

3. Cabinet approves terms of 16th Finance Commission



Recently, the Union Cabinet approved the terms of reference for the Sixteenth Finance Commission (SFC). At a press conference on Wednesday, Information and Broadcasting Minister Anurag Singh Thakur revealed that the chairman and members of the SFC will be appointed "as soon as possible". The SFC is expected to submit its comprehensive report by October 31, 2025, covering the five-year period with effect from April 1, 2026. The terms of reference issued by the Cabinet mainly contain constitutionally mandated provisions. These include the distribution of the net proceeds of taxes between the Central Government and the States, the principles governing grants-in-aid of State revenues from the Consolidated Fund of India and measures to for **Panchayats** supplement resources Municipalities in the States. Traditionally, Finance Commissions have been consulted on a number of matters beyond their constitutional mandates. For example, the Fifteenth Finance Commission (FFC) chaired by NK Singh considered the impact of the Goods and Services Tax (GST) on states, expenditure on performance-based incentives and populist measures. Additionally, an additional section was added to the agenda of the FFC, exploring the possibility of states contributing to the country's defense expenditure. The terms of reference also include a notable clause relating to the Disaster Management Fund. "The Commission may review the existing arrangements on financing of disaster management initiatives in terms of the Fund constituted under the Disaster Management Act, 2005 (53 of 2005) and make appropriate recommendations thereon," it said. This signals a possible shift in the Commission's role towards addressing critical issues such as disaster preparedness and recovery.


4. India, Sweden announce launch of LeadIT 2 in Dubai



Prime Minister Narendra Modi along with his Swedish counterpart Ulf Christerson launched the Leadership Group for Industry Transformation Partnership during the COP28 World Climate Action Summit held in Dubai. India and Sweden announced the launch of the Leadership Group for Industry Transition 2.0 (LeadIT 2.0) in Dubai on December 1. The announcement was made during the Leadership Group for Industry Transition (LeadIT) event co-organized by India and Sweden. The event was led by PM Modi and his Swedish counterpart Ulf Christerson. LeadIT brings together countries, companies and industry experts to achieve net-zero emissions from heavy industries by 2050. The initiative promotes collaboration between decision makers in the public and private sectors to create policies and practices to accelerate industry transformation. Prime Minister Modi stressed the importance of inclusive industry transformation as the main objective of LeadIT 2.0. The initiative aims to bridge the technological gap by promoting cooperation among nations for the development and transfer of low-carbon technologies. The focus on inclusivity underlines the importance of ensuring that emerging economies have access to sustainable environmentally friendly technologies. Founded in 2019, LeadIT has grown as a collaborative effort with 18 countries and 20 industry-leading Emphasizing the shared commitment to global net zero, Prime Minister Modi underlined the important role of government-industry partnerships. Initially focusing on key sectors such as iron, steel, cement and aluminium, the LeadIT initiative prioritized industry transformation and knowledge exchange. This has been instrumental in

accelerating the adoption of low-carbon technologies, in line with global environmental objectives.

5. Bharat Coking Coal Limited starts 5.0 MTPA Madhuband washery operations



Bharat Coking Coal Limited (BCCL), under the Ministry of Coal, has announced the commencement of commercial operations of the state-of-the-art 5.0 million tonne per annum (MTPA) Madhuband Washery. This washery has started commercial operations on 29 November 2023 in the presence and guidance of Samiran Dutta, Chairman and Managing Director, Bharat Coking Coal Limited (BCCL). The podcast, released earlier this year, pays tribute to the life and legacy of renowned playwright and actor Girish Karnad. In 2008, Arshiya Sattar co-founded the literary residency, Sangam House, with David William Gibson. The aim of this initiative is to provide a nurturing space for writers in regional languages. Over the years,

Sangam House has hosted over 200 writers from India and across the world. Notably, it is a proud member of the Villa Swagatam network of residences, an initiative launched by the French Institute in India in March 2023, comprising 16 Indian residences related to arts and crafts, performing arts and literature.

7. Foxconn announced to invest 1.5 billion dollars in India



Foxconn, a major manufacturing partner of iPhone maker Apple, plans to invest \$1.54 billion in India after boosting revenues in the South Asian market. The announcement of this investment comes two months after the Taiwanese company made public its plan to double its workforce and investment in India by next year. Foxconn works with many well-known tech giants including Apple for manufacturing. The company is working towards strengthening plants in India as many tech giants want to shift a part of their manufacturing to India. Experts consider this to be a part of the China Plus One policy. Foxconn, which is the largest EMS (Electronic Manufacturing Services) provider globally. The company invested extensively in China between 2001 and 2017, although this has slowed down since 2018 after increasing trade tensions between the US and China. Foxconn, which operates manufacturing complexes in India, had earlier this year pulled out of its \$19.5 billion chipmaking joint venture with Vedanta. However, the company had said that it will continue its work in India and is confident about India's ambitions. The company has said, "Starting afresh in a new place is a challenge, but Foxconn is committed to investing in India. We have been working on challenges like this since the 1980s. Foxconn is a part of Government of India's 'Make in India' initiative. We

will continue to strongly support the ambitions and meet the needs of stakeholders." Last August, Foxconn had announced an investment of \$600 million in two projects in Karnataka to manufacture chip-tools and casing components for the iPhone.

8. IIT Guwahati advances defence, starts drone technology training for armed forces personnel



Indian Institute of Technology Guwahati (IITG) launched a three-month training program on drone technology specifically designed for junior commissioned officers and other ranks of personnel in the armed forces. According to an official statement from IITG, the program aims to enhance air defense capabilities while offering post-retirement career opportunities in the rapidly growing drone technology sector. The program implemented by IITG's Center for Educational Technology, Center for Intelligent Cyber Physical Systems, Center for Drone Technology (CDT) and Technology Innovation and Development Foundation is the first of its kind. Iyer said the customized curriculum provide participants with the knowledge, perception and vision needed for success in the diverse drone industry or as technology entrepreneurs. Thirty officers from various armed forces are currently enrolled in the programme, which involves theoretical classroom sessions and practical drone handling. Training includes robotics, 3D printing, practical flying with instructors and solo flying.
