

1. Actor Junior Mehmood passes away at the age of 67





2. State Bank will take another 20 percent of SBI pension fund



State Bank of India will acquire additional 20 per cent stake in SBI Pension Fund from SBI Caps for Rs 229.52 crore, taking its stake to 80 per cent. State Bank of India said in a communication sent to the exchanges, SBI has proposed to acquire 20 per cent stake in SBI Pension Funds Private Limited from SBI Caps. SBI Caps is a wholly owned subsidiary of SBI. All regulatory approvals in this regard have been obtained. State Bank said that the purpose of this transaction is better management. This cash acquisition will be completed by December 15, 2023. State Bank said that this deal is based on the valuation report of M/s Deloitte Touche Tohmatsu India. At present SBI has 60 percent stake in the pension fund. SBI and SBI Funds Management Limited will be the sponsors of SBI Pension Fund. SBI Funds Management Limited, a joint venture between SBI and Amundi with 62.53 per cent and 36.73 per cent stake respectively, holds 20 per cent stake in SBI PF. The bank said that RBI and PFRDA have given their respective approvals. SBI PF was formed in December 2007 and has been appointed as the Pension Fund Manager to manage the pension fund under the National Pension System.

3. India will give a loan of Rs 2 thousand crore to Kenya



Prime Minister Narendra Modi, after extensive talks with visiting Kenyan President William Samoyi Ruto, announced India's decision to provide a line of credit of \$ 250 million (about Rs 2 thousand crore) to Kenya for the modernization of its agriculture sector. . Ruto arrived here on a 3-day visit aimed at expanding overall relations between the two countries. In a statement issued to the media after the talks, Modi said that India has always given high priority to Africa in its foreign policy and has expanded its overall relations with the continent on a mission mode in the last decade or so. PM Modi said, 'I am confident that President Ruto's visit to India will not only strengthen bilateral relations but will also give new impetus to our relations with Africa.' Later, Modi said in a post on 'X', 'President Ruto Had a meaningful conversation with today. We had the opportunity to review the full range of India-Kenya relations. We discussed ways to deepen economic ties between our countries. Our countries will also work together in technology, digital innovations, clean energy and other areas. PM Modi expressed happiness that Ruto's visit to India is coming shortly after the African Union joined the G20. PM Modi said that India will provide a line of credit of \$250 million to Kenya for the modernization of its agriculture sector. He said, 'Laying the foundation of a progressive future, today we considered strengthening our cooperation in all areas and also identified many new initiatives. There is steady progress in mutual trade and investment between India and Kenya. We will continue to explore new opportunities to harness the full potential of our economic cooperation. India has been a reliable and committed development partner for Kenya.

5. License of Urban Co-operative Bank based in UP cancelled.



The Reserve Bank of India (RBI) has taken an important step by canceling the license of the Urban Co-operative Bank (UCB) located in Sitapur, Uttar Pradesh. The decision will come into effect from close of business on December 07, 2023, marking a significant development in the banking sector. According to RBI, the main reason behind the cancellation of the license is that the Urban Co-operative Bank has closed its banking business. The central bank has expressed concerns about the financial health of the bank, leading to the decision to wind down its operations. Apart from canceling the license, the RBI has approached the Cooperative Commissioner and Registrar of Uttar Pradesh to issue an order to close the bank. Emphasizing the seriousness of the situation, the appointment of a liquidator is also on the agenda. On liquidation, RBI assures that every depositor will be entitled to receive the deposit insurance claim amount of his deposits. This eligibility is subject to a monetary limit of ₹5 lakh from the Deposit Insurance and Credit Guarantee Corporation (DICGC). Notably, as per the data presented by the bank, 98.32 per cent of depositors are eligible to receive the full amount of their deposits from DICGC. In its statement, the RBI highlighted the urban co-operative bank's inadequate capital and earning prospects as key factors in canceling its license. The central bank expresses concern about the bank's ability to make full payments to its depositors, concluding that the bank's continuity is detrimental to the interests of its depositors.

6. Panchayati Raj Ministry launches 'Gram Manch' GIS app



In a strategic move to enhance spatial planning at the Gram Panchayat level, the Ministry of Panchayati Raj launched the Geographical Information System (GIS) application known as "Village Map". This innovative application leverages geospatial technology to empower Gram Panchayats in their planning efforts.

"Gram Map" serves as an integrated geospatial platform, providing a comprehensive view developmental works in different areas. It enables Gram Panchayats to visualize and plan projects effectively, while offering a decision support system for Gram Development Panchavat Planning (GPDP). Complementing the "Gram Map", the Ministry has introduced "mActionSoft", a mobile-based solution designed to capture photographs with geo-tags incorporating GPS coordinates. This facility facilitates geo-tagging of assets at three critical stages: before commencement of work, during work and on completion. Using the "mActionSoft" application the geo-tagged properties get seamlessly integrated with the "Gram Map", offering a better view of the developmental works in the Gram Panchayats. This integration ensures transparency and accessibility of information related to assets created under the Finance Commission Fund. "Village Map" comprises a series of planning tools that use GIS technology to assist Gram Panchayat officials in formulating realistic and achievable development plans. These tools play a vital role in the planning process, aiding in identification of potential project sites, asset tracking, cost estimation and impact assessment.

8. 5th Nagaland Honey Bee Day organized in Kisama village



The 5th Nagaland Honey Bee Day was celebrated with great enthusiasm under the theme "Bee and Honey Trials Taste" at Naga Heritage Village, Kisama. In this program, Deputy Chief Minister, Planning and Transformation and National Highways, T.R. Zeliang, who congratulated the Mission and accomplished bee farmers at both the State and District levels. T.R. Zeliang highlighted the rich beekeeping tradition of Nagaland, and attributed its potential to become a hub of beekeeping activities. The state's abundance of nectarrich flowering plants, favorable climatic conditions, rich vegetation and ideal topography make it an ideal center for beekeeping. Acknowledging the unique age-old tradition of beekeeping, TR Zeliang stressed the need to transform it from a traditional hobby to a sustainable

livelihood. With an aim to improve beekeeping practices across the state, regular training programs on honey production and rearing have been provided to the villagers. The Deputy Chief Minister revealed that there are more than 1 lakh beekeepers in Nagaland, with an additional 25,000 beekeepers launched in 500 villages by the Nagaland Beekeeping Mission (NBHM). The current honey production in the state is 440 metric tonnes (MT) per year. However, intensive and concerted efforts are required to achieve the ambitious target of 2000 MT by 2030 set by the Mission.
