

1. Possibility of cut in global crude oil fuel price



The demand for reduction in retail prices of gasoline and diesel has intensified as international crude oil prices have recently fallen below \$80 per barrel and stabilized in the range of \$76-77. This demand is supported by the strong performance of oil marketing companies (OMCs) in H1FY23 and the maintenance of retail inflation within the comfort zone of the Reserve Bank of India (RBI) in November 2023. A senior government official highlighted that OMCs have experienced profitability in H1FY24 compared to the same period in FY23. This, combined with current international crude oil prices below \$80 a barrel, strengthens the case for a potential price cut in January 2024. Discussions during the budget (vote on account) consultation process included a review of fuel prices, but at the time, oil prices were volatile, hovering around \$81–82 per barrel. The current scenario of prices below \$80 is considered favorable for OMCs. It remains uncertain whether there will be a cut in excise duty, as seen in November 2021 and May 2022, or a summary of daily fuel price revision, which has been on hold since April 6, 2022. Although there is currently a strong case for price cuts given the decline in inflation, global prices stabilizing in the \$76-77 range and improving financial condition of OMCs, the market remains volatile due to uncertainties over global demand. If international prices remain around \$80 in the new year, it could further support the argument for a price cut.

2. JN.1 variant of COVID-19 virus



The World Health Organization (WHO) issued an alert on Sunday, December 17, expressing concern over the evolving nature of the JN.1 COVID subvariant and the increase in respiratory diseases globally. The organization urged member countries to prioritize sequence sharing and increase surveillance efforts to better understand and respond to the changing landscape of the virus. The JN.1 variant, identified as a subvariant of Omicron BA.2.86 or Pirola, was first detected in the United States in September 2023. According to Rajiv Jayadevan, co-chairman of the National Indian Medical Association Covid Task Force, JN.1 has unique characteristics, it spreads rapidly and displays the ability to evade immunity. This dangerous combination makes it capable of infecting people with previous Covid infection and those who have been vaccinated. Symptoms include fever, runny nose, sore throat, headache, cough and mild gastrointestinal problems. It is associated with moderate symptoms, and no increase in hospitalizations has been reported. Patients usually recover within 4-5 days, with some experiencing difficulty breathing. In India, JN.1 was detected in Kerala on December 8, where a 79-year-old woman experienced mild symptoms of influenza-like illness (ILI). The country is urged to remain vigilant and implement necessary measures to prevent such spread.

5. Egypt's Abdel Fattah el-Sisi wins third term as president with 89.6% of votes

Egypt's President Abdel Fattah al-Sisi has won a third term in office in the Arab world's most populous country with 89.6 percent of the vote, the national election authority said. The outcome of the December 10-12 vote was widely expected as the former army chief, with a fondness for infrastructure mega-projects, campaigned against a small field of relative unknowns. That secures 69-year-old Abdel Fattah el-Sisi his third and, according to Egypt's constitution, final term in office, which will begin in April and last six years. His victory comes despite a painful economic crisis, a currency collapse and skyrocketing home prices, and heightened regional tensions caused by the Israel-Hamas war in neighboring Gaza. Annual inflation is running at 36.4 percent, causing prices of some food items to rise by the week and hurting household budgets in the country of about 106 million. Even before the current economic crisis, nearly two-thirds of Egypt's population was living at or below the poverty line. A decade-long crackdown on dissent had eliminated any serious competition for Abdel Fattah el-Sisi, Egypt's fifth president to emerge from within the military since 1952. This was the third time in a decade that Abdel Fattah al-Sisi won a landslide victory, albeit by the narrowest of margins. In both 2014 and 2018, Abdel Fattah el-Sisi won more than 96 percent of the vote. Runner-up Hazem Omar, who leads the Republican People's Party, received 4.5 percent of the vote. Next came Farid Zahran, leader of the Egyptian Social Democratic Party, and Abdel-Sanad Yamama from the century-old but relatively marginal party Wafd.

6. India launches first winter mission to Arctic



India launches India's first winter mission to the Arctic, which will give a big boost to the country's research around global climate, sea levels and biodiversity. Union Earth Sciences Minister Kiren Rijiju flagged off the winter science expedition to the Arctic region, which aims to maintain a year-long presence at the Himadri Research Station in Svalbard, Norway. "The Ministry of Earth Sciences (MoES) will make necessary budgetary and other allocations, provide administrative support for winter expeditions in the Arctic, which will now be carried out on a regular basis annually," the minister said. India's first research station, Himadri, on the International Arctic Research Base, is located at a distance of 1,200 km from the North Pole. This station was opened in view of the sustained interest shown by Indian scientists in pursuing scientific studies in the Arctic and it provides extensive field and laboratory support required for pursuing research activities in the Arctic. MoES officials said the Norwegian government will provide logistical and other support to the visiting Indian team as this will be the first mission of the Indian team. "The Norwegian government has shown confidence in Indian scientists and our presence during winter will add value. Scientists and young science students will have to play a major role in making India a developed nation. India is making inroads into many frontiers by building its presence on the Moon, in the deep sea and in the polar region," Rijiju said.

7. WHO SE Asia Director Poonam Khetrpal Singh awarded National Order of Merit Gold Medal of Bhutan

Dr Poonam Khetrupal Singh, a 1975 batch retired Punjab cadre IAS officer and WHO South-East Asia Regional Director, has been awarded Bhutan's prestigious National Order of Merit Gold Medal for her distinguished services to the country. "Dr Poonam Khetrupal Singh, the first female Regional Director of the WHO South-East Asia Region, played a key role in supporting transformational healthcare leadership in Bhutan from 2014 to 2024. His tenure saw remarkable progress, with Bhutan becoming one of the first countries to achieve this goal. Eliminate measles and rubella ahead of time. He made significant contributions to helping Bhutan achieve excellence in COVID-19 vaccination," the king said. 8. Anand Marriage Act implemented in Jammu and Kashmir



Jammu and Kashmir administration has taken an important step towards fulfilling the long standing demand of the Sikh community by implementing the Anand Vivah Act. The Act provides statutory recognition to Sikh marriage rituals, allowing Sikh couples to register their marriage under specific rules rather than the Hindu Marriage Act. The Jammu and Kashmir administration has framed detailed rules for registration of marriages under the Anand Marriage Act. The set of rules, titled 'Jammu and Kashmir Anand Vivah Registration Rules, 2023', outlines the procedures to register "Anand Vivah". According to a government notification issued on November 30, tehsildars within their respective jurisdictions will act as registrars for such marriages. Sikh couples are allowed to apply for registration within three months after their marriage. However, if the formalities are completed after the expiry of this deadline, they may attract late fees. This timeline and fee structure has been specified in the notification issued by the Department of Law, Justice and Parliamentary Affairs. The origins of the Anand Marriage Act can be traced to 1909, when the British Imperial Legislative Council enacted legislation recognizing the Sikh marriage ceremony, Anand Karaj. The primary objective of the Act was to accept and respect the customs and practices of the Sikh community. In 2012, Parliament passed the Anand Vivah (Amendment) Bill, providing legal recognition to Sikh traditional marriages.
